1. Call to Order

The Chair presented that in December 2020, the Industry Council elected a Vice-Chair for a one-year term in accordance with sections 7.4(2) & (5) of *REA* Bylaws in effect at the time. The *REA* Bylaws were amended on November 25, 2021, to amend the Vice-Chair's term to two-years. The former Vice-Chair's term expired November 30, 2023.

The Industry Council discussed the appointment of a Vice-Chair for a two-year term.

<u>MOTION:</u> The Commercial Real Estate Broker and Commercial Property Manager Industry Council elects Cheri Long to the position of Industry Council Vice-Chair for a term commencing immediately and ending on November 30, 2025, by acclamation.
