13. Rules Review Steering Committee Update

The Industry Council considered recommendations from the Rules Review Steering Committee, in principle.

<u>MOTION:</u> On the recommendation of the RECA Rules Review Steering Committee, the Residential Real Estate Broker Industry Council, approves, in principle, for consultation the following recommendations:

- 1. A single licence with sectoral authorizations with all seven sectors.
- 2. That existing brokers, associate brokers, and associates' current authorizations are grandfathered.
- 3. That related licenses need to be at the same brokerage.
- 4. To allow brokers to approve individual incentives, rather than brokerage-wide incentives.
