5. RECA Board of Directors Report

The RECA Board of Directors ("Board") member updated the Industry Council on the activities of the Board. The report was received as information.

6. Ministerial Direction - Real Estate Act Section 54

The review of correspondence received from the Honourable Minister Dale Nally of Service Alberta and Red Tape Reduction, addressed to the Board and Industry Council Chairs, regarding the application of *Real Estate Act* ("*REA*") section 54, was deferred to the next meeting due to concerns raised by Industry Council member Jason Bamlett to the Board Chair.

7. RECA Board of Directors and Industry Council Calendar

Management presented that, in accordance with the *REA* Bylaws, the Board Chair will issue a schedule of regular meetings for the succeeding year. 9. Stakeholder Engagement Policy

Motion failed

Management presented proposed amendments to the Stakeholder Engagement Policy ("Policy"). The amendments shift the Policy from a prescriptive to principle-based engagement method. If endorsed by the Industry Councils, and approved by the Board, amendments to the Stakeholder Engagement Guidelines will follow, accordingly.

The Industry Council provided suggested amendments to the Policy, which will be shared with the Board for their consideration.

10. Broker Forums

Management reported on the activities of the residential real estate Broker Forums that were held in late May 2024 in Calgary and Edmonton. The Broker Forums were well-attend by industry.

11. Residential Measurement Standards ("RMS") Stakeholder Correspondence

16. Multiple Offers/Transaction Brokerages

The Industry Council reviewed practices relating to multiple offer disclosure, and transaction brokerages. Pursuant to the RECA Interpretation Bulletin; the seller determines the process. While sellers and buyers have a duty of honesty, there is no duty of fairness to each other. Whether a licensee is representing a seller or a buyer, licensees are required to act in the best interests of their client, which include following the lawful instructions of the seller relating to multiple offer disclosure. It is the seller's choice whether they disclose the multiple offer situation to other potential buyers.
