- You will have satisfied the Administrative Penalty and no further proceedings under Part 6 will be taken against you.
- You cannot be charged under the *Real Estate Act* with an offence for the contravention(s) in this Administrative Penalty.

### TO: Indrani Asis Roy

The Registrar of the Real Estate Council of Alberta (RECA) has determined there is sufficient evidence you have contravened **section 43(1) of the** *Real Estate Act* Rules and this is conduct deserving of sanction.

Rule 43(1)

Subject to these rules, a licensee who establishes a client relationship when trading in residential real estate, engaging in property management, when dealing in mortgages, or providing condominium management services, must enter into a written service agreement with that prospective client.

## Particulars of the contravention(s):

- 1. Between May 2023 and November 2023, you failed to complete written service agreements with clients contrary to section 43(1) of the *Real Estate Act* Rules:
  - a) On May 15<sup>th</sup>, 2023, you assisted borrower [K.S] in getting a mortgage for [ADDRESS 1]. You did not have a service agreement with this client.
  - b) On May 25<sup>th</sup>, 2023, you assisted borrower [S.D] in getting a mortgage for [ADDRESS 2]. You did not have a service agreement with this client.
  - c) On June 15<sup>th</sup>, 2023, you assisted borrowers [S.S & B.N] in getting a mortgage for [ADDRESS 3]. You did not have a service agreement with these clients.
  - d) On June 22<sup>nd</sup>, 2023, you assisted borrower [S.D] with getting a mortgage for [ADDRESS 4]. You did not have a service agreement with this client.
  - e) On September 22<sup>nd</sup>, 2023, you assisted borrowers [S.S & A.S] in getting a mortgage for [ADDRESS 5]. You did not have a service agreement with these clients.
  - f) On September 20<sup>th</sup>, 2023, you assisted borrower [S.D] with getting a mortgage for [ADDRESS 6] You did not have a service agreement with this client.
  - g) On November 8<sup>th</sup>, 2023, you assisted borrowers [P.B & P.S] with getting a mortgage for [ADDRESS 7]. You did not have a service agreement with these clients.

The Registrar considered the following aggravating factors:

# Aggravating Factors

• You failed to have a written service agreement in place with clients seven times.

# Appeal

You have the right to appeal this Administrative Penalty to a Hearing Panel. See section 83.1 of the *Real Estate Act* for what you must do to appeal.

In an appeal you will be given a full opportunity consistent with procedural fairness and natural justice to present evidence before the Hearing Panel in relation to the contraventions alleged.

Your written notice of appeal must comply with section 83.1 and must be received by the Registrar **within 30 days** of you receiving this Administrative Penalty.
